Standing Committee Reports:

Old Business: David Feist reported about what information he needs and when for posting our district events online. Directors of tournaments were given an instruction sheet of what information that David needs.

2 Board League: President Randy Carder from The Resort has seven teams available to start December 4th. They are always looking for other teams if anyone knows of any.

New Business: Jim Heiar promoted the snowman classic tournament for players that have not won a trophy being held at The Reserve formally (Lost Dutchman). Jim is now the president of the Western which will be held in district IV in 2026. A lengthy discussion followed.
